There have been numerous community engagement opportunities during the 2020-2021 school year to gather and streamline feedback to inform the development of the Expanded Learning Opportunities Grant Plan (ELO) and the Local Control Accountability Plan (LCAP). The extensive feedback from the ELO and LCAP was used in the development of this ESSER III expenditure plan. Community engagement opportunities throughout the 2020-2021 school year targeted the following stakeholder groups: students, parents/guardians, school and district administrators, teachers, support staff, bargaining units, parents/guardians of students with disabilities and students experiencing homelessness. Lewiston does not have a large percentage of Tribal affiliation in our community therefore we did not receive input from tribal community. The platforms used to solicit meaningful feedback from the Lewiston community included: family and staff surveys, student achievement data analysis meetings/dialogue to identify students in need of academic or social-emotional supports, board meetings, parent meetings, staff meetings. We evaluated our stakeholder engagement opportunities and determined that civil rights groups are neither present nor served by the LEA. Feedback from the community engagement strategies described above was incorporated into the development of the specific strategies for addressing the loss of instructional time and providing supplemental instruction and support to identified students. Additional feedback from the ELO and LCAP remained consistent with current feedback, including a commitment to increased academic check-ins and progress monitoring to ensure that students stay on track for graduation and growth towards grade level, increase professional development especially new teachers including a robust mentor teacher program to increase retention of new teaching staff, and set a prioritization on students increased access to effective counseling, mental health while keeping student on track for graduation and growth towards grade level. The services and opportunities for students as described in the ESSER III plan incorporate this feedback and continues to build on the ELO and LCAP goals of supporting safe and continuous in-person learning and addressing the academic, social, emotional, and mental health needs of all students.

The district continues to work towards modernization of campus facilities through grants and other funding to ensure safety of students, staff and visitors.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. - Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
