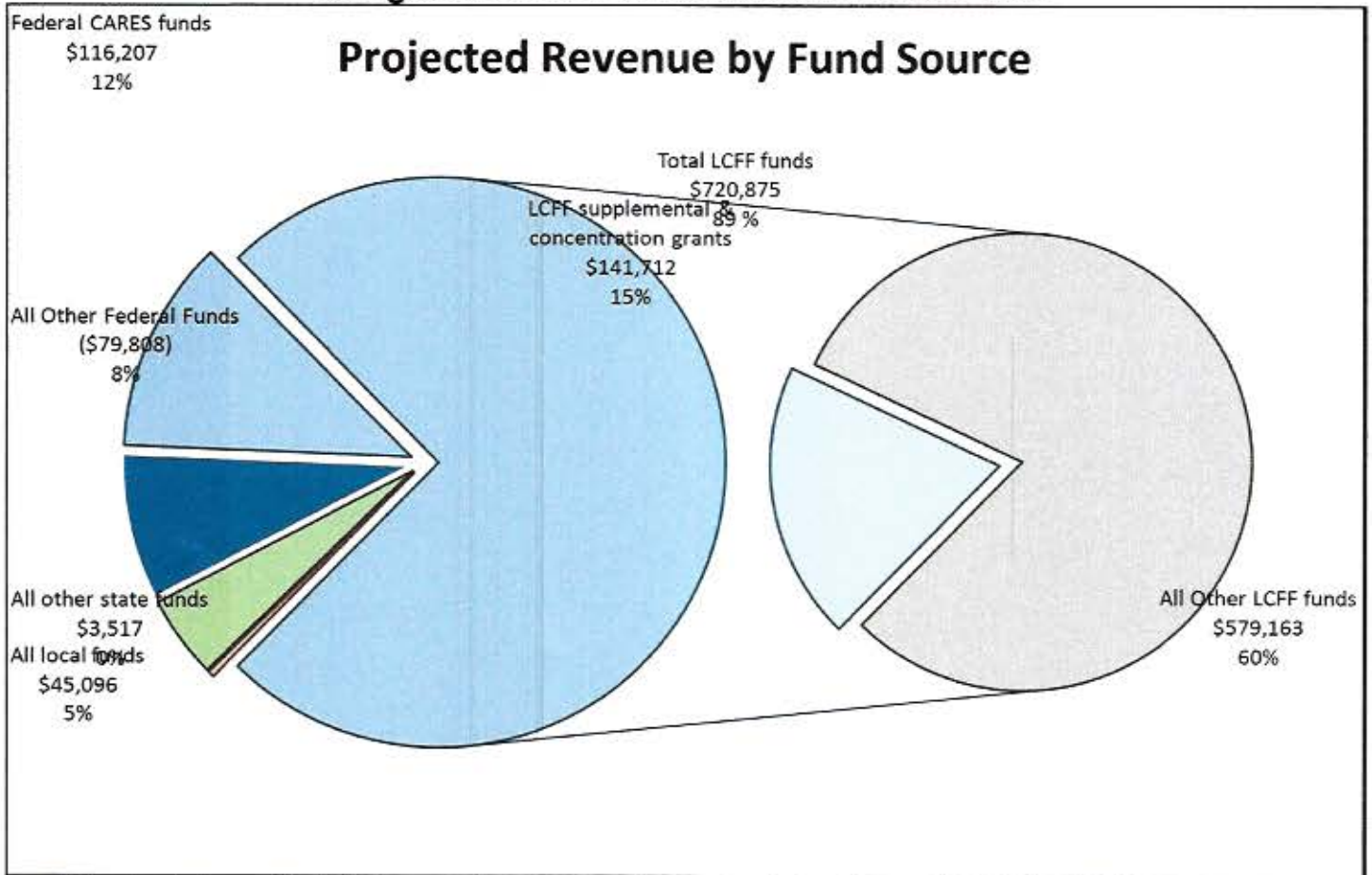

School districts receive funding from different sources: state funds under the Local Control Funding Formula (LCFF), other state funds, local funds, and federal funds. LCFF funds include a base level of funding for all LEAs and extra funding - called "supplemental and concentration" grants - to LEAs based on the enrollment of high needs students (foster youth, English learners, and low-income students).

## Budget Overview for the 2020-21 LCAP Year

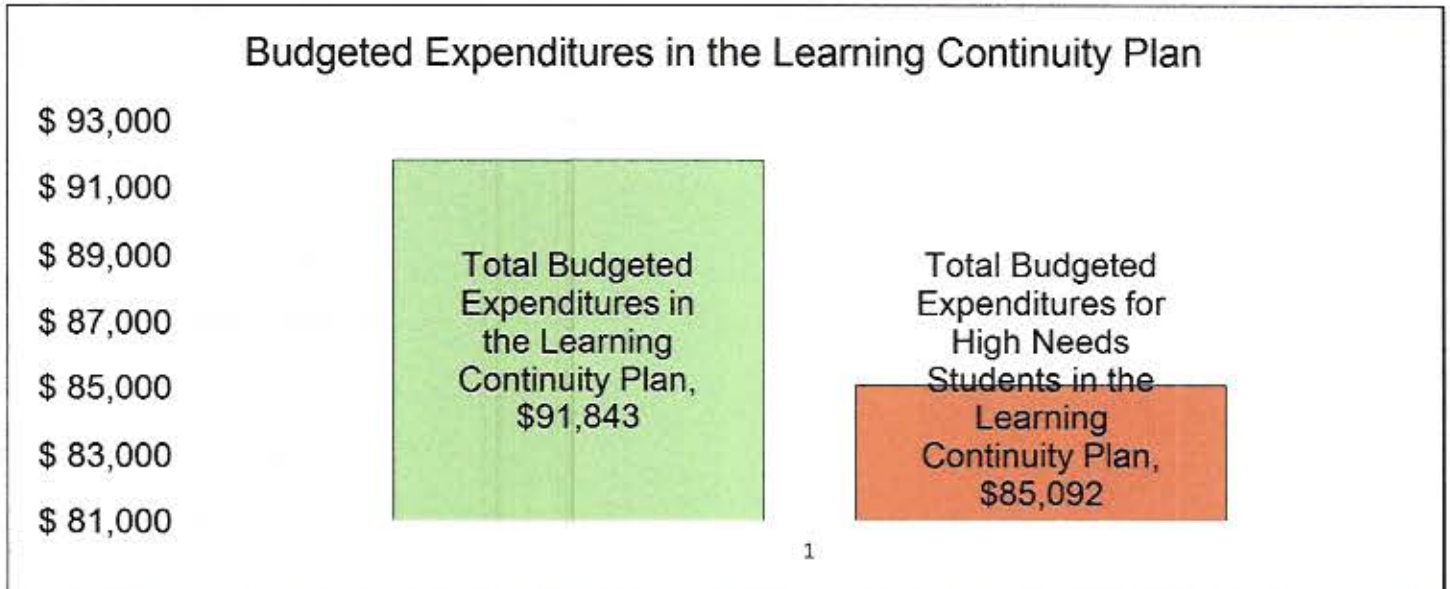


This chart shows the total general purpose revenue Lewiston Elementary School District expects to receive in the coming year from all sources.

The total revenue projected for Lewiston Elementary School District is \$805,887, of which \$720,875 is Local Control Funding Formula (LCFF), \$3,517 is other state funds, \$45,096 is local funds, and \$36,399 is federal funds. Of the \$36,399 in federal funds, \$116,207 are federal CARES Act funds. Of the \$720,875 in LCFF Funds, \$141,712 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

For the 2020-21 school year school districts must work with parents, educators, students, and the community to develop a Learning Continuity and Attendance Plan (Learning Continuity Plan). The Learning Continuity Plan replaces the Local Control and Accountability Plan (LCAP) for the 2020–21 school year and provides school districts with the opportunity to describe how they are planning to provide a high-quality education, social-emotional supports, and nutrition to their students during the COVID-19 pandemic.



This chart provides a quick summary of how much Lewiston Elementary School District plans to spend for planned actions and services in the Learning Continuity Plan for 2020-2021 and how much of the total is tied to increasing or improving services for high needs students.

Lewiston Elementary School District plans to spend \$1,169,424 for the 2020-21 school year. Of that amount, \$91,843 is tied to actions/services in the Learning Continuity Plan and \$1,077,581 is not included in the Learning Continuity Plan. The budgeted expenditures that are not included in the Learning Continuity Plan will be used for the following:

The majority of the General Fund expenditures are not included in the LCP. These include predominantly salaries and benefits. Other expenditures include general operating expenses (utilities, etc.), instructional materials, special education costs, after school program costs, transportation and maintenance costs, and administrative costs

## Increased or Improved Services for High Needs Students in in the Learning Continuity Plan for the 2020-2021 School Year

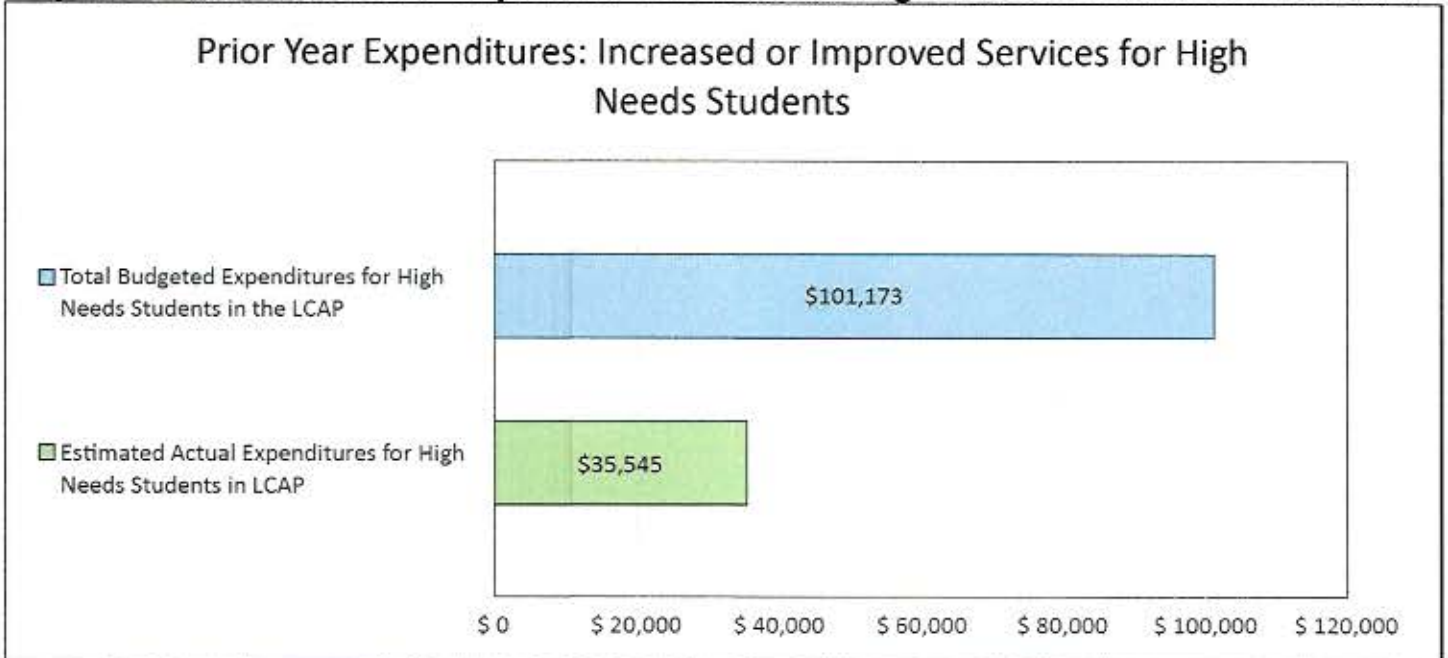
In 2020-21, Lewiston Elementary School District is projecting it will receive \$141,712 based on the enrollment of foster youth, English learner, and low-income students. Lewiston Elementary School District must describe how it intends to increase or improve services for high needs students in the Learning Continuity Plan. Lewiston Elementary School District plans to spend \$85,092 towards meeting this requirement, as described in the Learning Continuity Plan.

For 2020-21 Lewiston Elementary School District will take the following additional actions to improve services for high needs students: extend distance learning teachers for the full school year, increase intervention and tutoring programs, provide supplemental materials and supplies to enhance teaching and learning, utilize assessment programs to identify needs and guide services, and provide connectivity and online access. teachers for the full school year, increase intervention and tutoring programs, provide supplemental materials and supplies to enhance teaching and learning, utilize assessment programs to identify needs and guide services, and provide connectivity and online access.

## Update on Increased or Improved Services for High Needs Students in 2019-20



This chart compares what Lewiston Elementary School District budgeted in the 2019-20 LCAP for actions and services that contributed to increasing or improving services for high needs students with what Lewiston Elementary School District actually spent on actions and services that contributed to increasing or improving services for high needs students in the 2019-20 school year.

In 2019-20, Lewiston Elementary School District's LCAP budgeted \$101,173 for planned actions to increase or improve services for high needs students. Lewiston Elementary School District actually spent \$35,545 for actions to increase or improve services for high needs students in 2019-20.

In 2019-20, the severe unexpected and ongoing disruption to school operations caused by the COVID19 pandemic caused some disconnect between planned expenditures and what actually happened. Lewiston Elementary School District was able to carry out most or some of the actions and services called for in their adopted 2019-20 LCAP.
